The client's IT team was overwhelmed by coordinating multiple vendors and struggled to maintain consistent data destruction and recycling processes.

The Challenge

This project required implementing a standardized IT asset disposition (ITAD) program for a large, globally distributed workforce while meeting strict data security and privacy regulations. The client needed a single, centralized partner capable of executing on-site data destruction and compliant recycling across multiple continents, including regions with complex import/export laws and limited recycling infrastructure.

Certifications: **NAID AAA** for Data Destruction and **e-Stewards** & **R2** for responsible recycling.

Reporting: Ensure the company you are working with can provide **detailed reporting** on all assets processed, sold, and media destroyed.

Portal Access: Can the vendor provide real-time visibility to each project, along with searchable **inventory reporting**?

On-site Services: Can the vendor provide **on-site media destruction, de-racking, de-cabling, packing, and removal**?

Return on Investment: Does the vendor have **experience selling data center infrastructure** in volume to create the highest possible return?
